VENDOR BOOTHS

1- The only thing furnished for the 10 x 10 Vendor Booths is a Festival tent with 4 sides. The front side may be taken down for show hours and re-installed during non show hours. You may take down up to 3 sides with Show Management Approval

2- **You will get your booth assignments when you check in for set-up at the Show Office**

3- Corner Booths may be requested on the contract under notes, but will not be guaranteed

4- You may drive right up to your booth to load and unload Thursday 12-6pm and Sunday after 5pm. If you need alternate hours please call show management to discuss options if any.

5- If your deposit is not paid within 7 days of contract, your contract will be voided

6- If your final payment is not paid within 60 days of the show, your contract will be voided and deposit and payments forfeited

FIRE REGULATIONS

MOTORIZED and TOWABLE DISPLAY UNITS:

Vehicles are allowed as part of your display with the following requirements met:

-Must fit completely inside booth dimensions – including mirrors, door steps, bumpers, hitches etc.

-Gas tank level 1/4 of a tank or less

-Gas tank 'lid' taped – sealed (please bring duct tape)

-Battery disconnected (please bring tools)

-No Propane

MFG AND RV DEALER TEMPORARY BRANCH PERMIT:

All RV DEALERS selling at the show must fill out and turn in the California form OL73. A separate email will be sent over the next few days with both a pdf version of the form and a copy of your event contract, which must be submitted with the completed form. This must be done 10 days before the opening day of the show.

MFG DISPLAYS:

MFG displays that are just for public display and not for onsite sales do not have to have a permit to participate in the show.

TEAR DOWN POLICY

We all have somewhere to be this time year

With that said this show closes at 5:00pm.

We stop selling tickets at 4:00pm and at that time and only that time are you allowed to dismantle your booth and begin taking stuff to your vehicles by hand or cart

Only at 5:00pm will you be allowed to move units or drive cars into the show footprint

If you begin to dismantle your booth before 4:00pm, you will not be allowed to come back to this show and or any others events that RV Supershow operates ever!
