VENDOR BOOTHS

- 1- The only thing furnished for the 10 x 10 Vendor Booths is 3' side drape as well as the 8' back drape
- 2- You will get your booth assignments when you check in for set-up
- 3- Corner Booths may be requested on the contract under notes, but will not be guaranteed
- 4- If your deposit is not paid within 7 days of contract, your contract will be voided
- 5- If your final payment is not paid within 60 days of the show, your contract will be voided and deposit and payments forfeited

FIRE REGULATIONS

MOTORIZED and TOWABLE DISPLAY UNITS:

Vehicles are allowed as part of your display with the following requirements met:

- Must fit completely inside booth dimensions – including mirrors, door steps, bumpers, hitches etc.
- Gas tank level 1/4 of a tank or less
 - **THIS WILL BE CHECKED BEFORE YOU GET IN THE BUILDING**
- Gas tank 'lid' taped – sealed (please bring duct tape)
- Battery disconnected (please bring tools)
- No Propane
 - **REMOVE ALL PROPANE TANKS THAT ARE REMOVABLE- BEFORE YOU GET TO THE SHOW! LEAVE THEM AT THE DEALERSHIP**

SET-UP

EXHIBITOR CARGO TRAILERS: SEE MOVE IN/OUT LINK ON WEBSITE FOR MAP

All exhibitor cargo trailers and freight trucks must be parked in a loading dock after they have been unloaded. See Show Office for dock location/pass and or additional instructions.

You may not unload any materials at the loading docks without UNION labor. All cargo trailers and or freight trucks must be brought inside the hall to load and unload, then be immediately removed from exhibit hall and parked on loading dock.

EXHIBITOR VEHICLES:

You may not park any vehicles inside the hall unless you are actively loading or unloading. All vacant vehicles must be taken outside immediately following unloading or loading.

EXHIBITOR FOOT TRAFFIC:

NO FOOT TRAFFIC IS ALLOWED THROUGH THE LARGE ROLL UP SOUTH ROLL UP DOOR OR ALSO KNOWN AS DOCK 61. This is ingress and egress for vehicles only. Any and all foot traffic must use dock door 62.

*30 days prior to show specific move-in slots will be given

Everything must be removed from inside the center by 2pm Tuesday

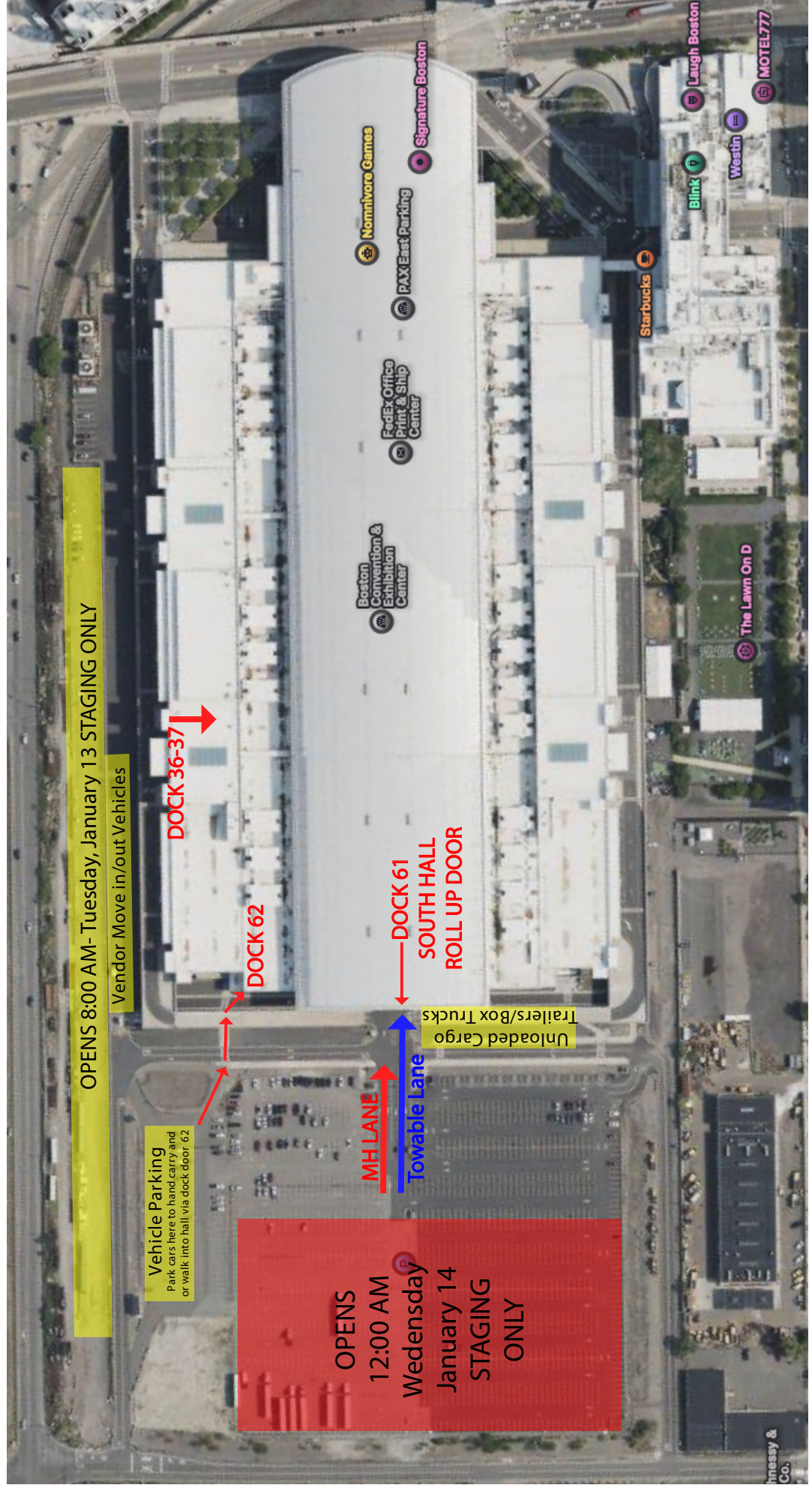
***PLEASE DO NOT** start tearing down until we have announced over the PA system that the show is officially closed. We cannot allow you to carry anything out of the building before said announcement.

NEW ENGLAND RV SUPER SHOW

RV STAGING, Move in/out Map

- 1- All RV's and Cargo Trailers should be staged in yellow location marked RV Staging
- 2- Pay attention to security directions if given, as this location is fluid may change,
- 3- The section marked VEHICLE PARKING is where exhibitors park individual cars after unloading and walk in using Dock Door 62
- 4- All RV's will load in using Dock Door 61. There will be a pass through lane for all towables, marked in Blue
- The Red lane will be the Motorized checkpoint point lane where fuel/propane will be inspected.
- 5- Thursday, ONLY Dock 36-37 will be available for 10 x 10 vendor Move in. Vehicles will not be allowed into the hall. Vendors must hand carry or provide their own carts for 10 x 10 Vendor booth set up/down
- 6- Monday at 3:00pm 10 x 10 Vendors will be allowed to park vehicles in "Vendor move out area", along the fence.

***ANY VEHICLES NOT ACTIVELY LOADING OR UNLOADING MUST PARK IN THE VEHICLE PARKING AREA AND WALK INTO HALL THROUGH DOCK 62**





TEAR DOWN POLICY

We all have somewhere to be this time year

With that said this show closes at 4:00pm.

10 x 10 Vendor Booths-

At 3:00pm you will be allowed to stage vehicles in the blue areas. You will not be allowed to stage vehicles in this area until 3:00pm

We stop selling tickets at 3:00pm and at that time and only at that time are you allowed to dismantle your booth and begin taking stuff to your vehicles. You are only allowed to hand carry items to your vehicles until 4:30 pm, when the roll up door opens at dock 41-42

If you begin to dismantle your booth before 3:00pm, you will not be allowed to come back to this show and or any others events that I hold- EVER!

RV DEALERS-

You will be allowed to begin dismantling your display at 3:00pm. No RV's, Trucks, or Vehicles will be allowed to move until 4:30, when dock 61 and dock 41-41 open. At that point RV's will be allowed to be removed and placed back in designated staging lot.

These are not an unreasonable request, and I appreciate your full cooperation.
